### STATEMENT OF PROBABLE CAUSE

Filed in District Court State of Minnesota 2/27/2025

The Complainant states that the following facts establish probable cause:

Your complainant is a licensed peace officer employed by the Rochester Police Department. In that capacity your Complainant has reviewed the police reports relating to John Matthew Timmerman, the above-named defendant, and the allegations contained therein. Based upon that information, your complainant believes the following to be true and correct.

On October 7, 2024, Det. Neumann of the Rochester Police Department received a cybertip relating to the solicitation of minors to produce child sexual abuse material (CSAM). Through investigation it was learned that there were cybertips from 2022 and 2023 were related to the same suspect as the current cybertip, JOHN MATTHEW TIMMERMAN (DOB 5/11/81). Investigation showed that the IP address associated with the cybertips belonged to charter and registered to a SW, Rochester, MN, Olmsted County residence. The residence was listed as belonging to Timmerman. A warrant was sent to google for the email <a href="mailto:jmt\*\*\*\*\*\*@gmail.com">jmt\*\*\*\*\*\*@gmail.com</a>, which was associated with the cybertip. Google provided information that the username associated with that account was John Timmerman and a phone number which was also listed in the cybertip.

On November 21, 2024, a search warrant of Timmerman's residence was conducted. Multiple electronic devices associated with him were located. Timmerman agreed to talk to Det. Neumann. He told Det. Neumann that he used the email <a href="mailto:jmt\*\*\*\*\*@gmail.com">jmt\*\*\*\*\*@gmail.com</a> and gave the phone number that was on the cybertip. Timmerman stated that he does use social media, such as Facebook and Instagram on his phone. He denied chatting with people online. Timmerman told Det. Neumann he could look at his personal phone but did not want to give him access to his work phone.

On November 26, 2024, a search warrant was granted for Timmerman's devices. Det. Neumann found that Timmerman's personal cell phone (item 1), and two work phones contained data related to the investigation (items 2 and 4). Item 2 contained Facebook accounts and communications between December 2023- November 2024. Item 4 had Facebook accounts and communications from December 2023. On Item 2, 44 Facebook accounts were located that appear to have been created by Timmerman, which impersonate and portray minors. In Item 4, 5 Facebook and Instagram accounts were located that appear to have been created by Timmerman that also impersonate and portray minors. Det. Neumann located several of the accounts Timmerman created sending messages to minors. Based on the nature of some of the chats it appeared that parts of the chat were missing. Det. Neumann knows through training that if a user blocks another user on Facebook messenger that the chats will no longer be visible, thus Det. Neumann deduced that Timmerman would message victims under a different username but continue the previous conversation.

Det. Neumann, OCSO, the MN BCA, and the FBI were able to identify 169 victims between the ages of 8-17, both male and female. Through investigation, law enforcement was able to identify victims throughout

the United States, Canada, the United Kingdom, Nigeria, and other countries. Throughout the sexual conduct would Timmerman would solicit many of the victims to produce or disseminate CSAM. The sexual conduct would range from Timmerman telling victims to engage in sexual conduct including masturbation, sex acts with pets and sexually assaulting other minors. Many of the victims did comply with Timmerman's requests. After the victim would send Timmerman CSAM, he would threaten to disseminate it to the child's friends, family, sports teams, etc... Some of the victims would beg Timmerman not to send their photos to people and would threaten to end their life, Timmerman would continue to threaten the victims with disseminating their photos. Through chats, Timmerman extensively coerced his minor victims to engage in end-to-end encrypted (live) Facetime calls for sessions that lasted sometimes in excess of 20 minutes. During some of these calls he would record or screenshot their images.

Law enforcement identified Victim 1 (juvenile male under the age of 15) who resides in Olmsted County, MN. Timmerman was messaging Victim 1 from September 2024 to mid-October 2024. Det. Johnson of the OCSO spoke with Victim 1 in January 2025. Victim 1 stated that Timmerman messaged him in 2024 saying that he was cute. At that time, Victim believed that Timmerman was a teenage female based on the profile photo. Victim 1 was 13 years-old when they first started messaging. Within the first few minutes of chatting Timmerman told Victim1 that he wanted to see his penis. Victim 1 sent Timmerman 2-3 photos of his penis and a video of him masturbating. Victim 1 asked Timmerman if he was going to send photos back, Victim 1 then blocked Timmerman. About a month later, he received about 100 messages that would say "hello" "remember me" Timmerman would then send Victim 1 the photos and video he previously took of himself. Timmerman threatened to send the photos to Victim 1's ex-girlfriend. Victim was identifiable in the photos and video by distinct marks on their body.

#### Item 2

In April 2024, Timmerman contacted 1 Victim, a 15-year-old female. During the chat conversation he asked the victim if she would show her body on camera and then telling her to show her naked body to the camera. He would then ask victim about what kind of sexual acts they have done.

In July 2024, Timmerman contacted 14 victims between the ages of 13-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done. During at least one conversation he directed a victim to touch their genitals and then told victim that he would send the video or photo to victim friends and family if victim did not continue doing what Timmerman directed. Often victims face would be shown in the videos or photos.

In August 2024, Timmerman contacted 88 victims between the ages of 10-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done. Timmerman was chatting with an approximately 11-year-old in which he directed that victim to engage in sexual contact with himself and send the photo or video to Timmerman. Once the image was

received Timmerman threatened to send the image to victims' friends and family. Often victims face into the image to victims' friends and family. Often victims face into the victims face into the victims and family.

In September 2024, Timmerman contacted 18 victims between the ages of 12-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done. Timmerman had a conversation with a 14-year-old female in which he directed her how to pose and touch her exposed intimate parts. Timmerman threatened to send those images to her friends and family if she did not comply. Often victims face would be shown in the videos or photos.

In October 2024, Timmerman contacted 21 victims between the ages of 12-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done. Timmerman had a conversation with a 15-year-old male in which he directed victim to send him photos of his penis and him touching his penis. When Timmerman got the photos, he threatened to disseminate those images to people victim knew. Often victims face would be shown in the videos or photos.

In November 2024, Timmerman contacted 17 victims between the ages of 9-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done. Timmerman chatted with a 14-year-old female in which he directed to to expose and touch her intimate parts. Timmerman received those images and again threated to send those images to people victim knew. Often times victims face would be shown in the videos or photos.

#### Item 4

In December 2021, Timmerman contacted 7 victims between the ages of 13-17. During the chat conversations he asked the victims if they would show her body on camera. If they victim kept talking to Timmerman, he would tell the victim to show their naked body to the camera. Timmerman would then direct the victim how to pose and what to wear. Some of the times he would tell the victims to penetrate themselves. During the conversations Timmerman would ask the victims about what kind of sexual acts they have done.

In April 2023, Timmerman contacted 1 victim. He tells victim to send him nude photos of herself. She sent a photo of herself in her bra and underwear. After she complies, Timmerman tells her that he must do whatever he says, or he will send and post the videos to her friends and family. He tells her he saved the video. Victim was 15 years old.

In June 2023, Timmerman contacted 1 victim. Victim stated that she was 16. Timmerman asks if she will show her body on camera. When victim says no, Timmerman says that he will hack her make her lose everything if she does not do whatever she wants him to. He continues to tell victim that she will lose everything if she does not comply. He then asks victim what sexual acts she has done. He directs her to turn her camera on and take her clothes off, so she is nude in front of the camera. Timmerman says that he took pictures and videos of her.

Det. Neumann located 95 files that are consistent with CSAM on Item 2. Many of the images depicted sex acts with minors under the age of 18, approximately 11 files were of children under the age of 13 engaging in sex acts. On Item 4, 11 CSAM files were located that depicted minors under the age of 18 engaging in sex acts.

Around 300 chats were located which appeared to be coercive or threatening, but due to the age of that specific victim, or inability to see previous chats, law enforcement was not able to determine if those chats were criminal in nature.

Timmerman resided in Rochester, MN and worked in Olmsted County or Goodhue County during the course of these offenses.
